HAVING REGARD TO Presidential Decree 445 of 28 December 2000, apply; **HAVING REGARD TO** arts. 2 and 12 of Prime Ministerial Decree of 9 April 2001, "Uniformity of financial aid":

HAVING REGARD TO D.Dir. no.406 prot. no.6478 issued on 26/01/2017, in which the donation A.S.D.F.I.A.M.® Fabbrica Italiana Associazioni Modellistiche is formally accepted;

HAVING REGARD TO the resolution of the Board of Governors on 31/01/2017;

HEREBY DECREES

The issue of a call for applications for **n.1** "**F.I.A.M.**® **per la cultura aeromodellistica**" – year 2016 - degree award.

art. 1 Features of the degree award and beneficiaries

The "F.I.A.M.® per la cultura aeromodellistica" degree award with gross amount of €1,000 (including tax due from the Politecnico di Milano) is for students that have obtained the Laurea Magistrale degree at Politecnico di Milano in Aeronautical Engineering- Ingegneria Aeronautica in the 2016 years and whose thesis concern to improve aerodynamic characteristics of the racing aircraft model

art. 2 Participation procedures

Applicants must submit their request for participation through the specific section in the Online Services www.polimi.it/onlineservices (Benefits and agreements> Economic benefits) by no later than 12.00 noon (Italian time) on 3 March 2017.

Applicants must attach, through the specific procedure:

1. Degree thesis in PDF format - max 10 MB;



The file must be named as Surname-Name-Type of document.pdf (for example Rossi-Mario-thesis.pdf)

The application is complete with the submission of the request for participation in this call for applications and implies the acceptance of its rules and regulations.

Applicants are responsible for checking the procedure is properly completed.

Once the application has been completed and submitted it may no longer be changed. Applicants will be allowed to delete the request and submit it again (ex novo) before the deadline.

Failure to complete the application or to submit it means applicants will be excluded from the selection process.

In case of graduation work with multiple authors, each co-author, that wants to participate to allocation of the award, must submit individually the application form.

art. 3 Judging Panel

The awarding will be decided by a Selection Committee appointed after Call deadline by Executive Decree.

If, provided that conditions under Art. 1 of this Call are met, more than one candidate has equivalent qualifications, the Committee could allocate, among them, the amount of the award.

The judging panel may not award the prize if it believes none of the submitted thesis deserve it.

art. 4 General rules

Cumulability: the degree award cannot be added to other prizes awarded for the same degree thesis.

Renunciation: if the winner renounces the prize, it will be awarded to the next highest ranking, eligible applicant in the ranking list.

Award: the winner will be informed of the degree award via an e-mail sent to his university e-mail address. No later than 10 days from receiving the e-mail, the winner must sign for acceptance and send the specific forms they will find attached to the award e-mail.

The Politecnico di Milano shall award the prize in a single instalment.



Taxation: the prize awarded is subject to the current laws governing the taxation of scholarships/degree awards. The sum paid as the degree award is to be treated as income comparable to income from employment for taxation purposes.

The tax due by the Politecnico di Milano is IRAP (equal to 8.5% of the value of the scholarship).

art. 5 Processing of personal data

Pursuant to Lgs. D. 196/2003, the Undergraduate and Graduate Student Service (the Data Controller of the supplied personal data), guarantees that the data will be used only to fulfil the obligations related to this procedure.
