HAVING REGARD to the Decree of the President of the Republic 28.12.2000, n. 445;

HAVING REGARD to Articles 2 and 12 of the Ministerial Decree of 9 April 2001 "Equal treatment regarding the right to higher education";

HAVING REGARD to Regulations for Administration, Finance and Accounting, issued by Rectoral decree n. 828 prot.n. 7766 of 14/03/2014 and, in particular, Articles 75 and 79;

HAVING REGARD to letter prot.n. 53701 of 16/06/2017, by which the Alessandro Baroni, Legal Rapresentative of the equensWorldline SE, has expressed its intention to give the Politecnico di Milano the total amount of € 4.425,00 to promote the allocation of one scholarship named "Francesca Dell'Osa" who in the 2017/2018 a.y. are enrolled in the second year of the Laurea Magistrale (equivalent to Master of Science) in the Schools of Engineering of the Politecnico di Milano;

HAVING REGARDS to Decree n. 3511 protocol n. 55395 of 21/06/2017 by which is declared the donation acceptance provided by the equensWorldline SE;

HAVING REGARD to deliberation of Board of Governors of 27/06/2017;

HEREBY DECREES

The issuance of competition notice for n. 1 scholarship "Francesca Dell'Osa" a.y.2017/2018.

art. 1 Recipients and scholarship features

The scholarship, with gross amount of € 5,000, deductible expenses excluded charged to Politecnico di Milano, are intended for students enrolled to the Laurea Magistrale (equivalent to Master of Science) in the Schools of Engineering of the Politecnico di Milano.



art. 2 Requirements for participation

The competition is open to students that meet the following conditions within the deadline of the call:

- 1. be enrolled to the a.y. 2017/2018 in the second year of the Laurea Magistrale (equivalent to Master of Science) in the Schools of Engineering of the Politecnico di Milano;
- 2. enrolment in a.y. 2016/2017 in the Laurea Magistrale (equivalent to Master of Science) in the Schools of Engineering of the Politecnico di Milano;
- 3. at least 50 CFU regularly registered and useful for graduation in his career;
- 4. weighted average of the passed exams registered not less than 27/30

The Area Sviluppo e Rapporti con le Imprese will attest the possession of requirements available in the computerized archive of Politecnico di Milano.

art. 3 How to participate

Candidates are required to submit the application form through the dedicated function available from On-line services http://www.polimi.it/servizionline (Exemptions and partnership agreements -> Student bursaries, degree awards, exemptions) within 12.00 noon (Italian time) of 03 October 2017.

The closure of the on-line application is equivalent to send the participation application for this Call and implies acceptance of its contents.

It is responsibility of the candidate to verify the correct conclusion of the procedure.

After closure of the Notice, application cannot be changed any more. The candidate can delete the application and resubmit a new one before the Call deadline.

Failure to close the application or its incompleteness will implies the exclusion from the evaluation procedure.

art. 4 Granting of scholarship

The assignment of scholarship will be decided on the basis of a ranking list made by the Right to Higher Education and Cross-border Mobility.

This ranking list will be drawn up taking into account the weighted average. With same average, priority will be given to the highest number of CFU. In case of further equal values, the younger candidate will come first.

The scholarship could not be assigned, in the event that all or part of the candidates will



not be considered eligible.

art. 5 General Rules

Accumulation - This scholarship may not be combined with other forms of financial assistance awarded by the Politecnico, in particular with benefits involving the right to higher education, or by any other public or private organisations for the relevant academic year of this competition. The scholarship can however be combined with contributions for international mobility provided by Politecnico or other public or private entity. The scholarship can also be combined with exemptions from university fees and contributions.

Revocation: the scholarship can be revoked if the recipient is subject to disciplinary sanctions. It is still subject to revocation in case of renunciation of studies or transfer to another University during the current year.

Cancellation: in the event of cancellation made by the winner, the scholarship is awarded to the first suitable candidate that follows in the ranking list.

Allocation: The assignment of the scholarship will be notified to the winner via institutional e-mail address of the University. Within 10 days from having received this notification, successful candidate must sign for acceptance and send the special forms they receive attached. The scholarship will be allocated with a single instalment by Politecnico di Milano.

Tax treatment: assigned contributions are subject to tax purposes and applicable legislation for what concern scholarships. The allocated amount for scholarship can be considered as income from salaried employment and therefore it undergoes the same tax treatment. The expenses charged to Politecnico di Milano corresponds to IRAP rate equal to 8,5% of the amount of the scholarship.

art. 6 Data Treatment

In accordance with Legislative Decree No. 196 of 30/06/2003, the Undergraduate and Graduate Students Services is responsible for personal information provided and guarantees that they will be used exclusively for purposes related to this procedure.

Personal data supplied to equens Worldline SE with specific authorisation under Lgs. D. 196/2003, including sensitive data, may be used by the company for staff search and selection purposes.
