HAVING REGARD to the Decree of the President of the Republic 28.12.2000, n. 445;

HAVING REGARD to Articles 2 and 12 of Ministerial Decree of 9 April 2001, "Equal treatment regarding the right to higher education";

HAVING REGARD to Regulations for Administration, Finance and Accounting, issued by Rectoral decree n. 828 prot.n. 7766 of 14/03/2014 and in particular Articles 75 and 79;

HAVING REGARD the availability of Rector's resources;

HEREBY DECREES

The issuance of competition notice for n. **10 scholarships "Mobility: infrastructures and services" a.y. 2017/2018.**

art. 1

Recipients and scholarship features

The n.10 scholarships, each one with gross amount of **€ 2,500**, included expenses charged to Politecnico di Milano, are intended for **students of the 2nd year of Laurea Magistrale** (equivalent to Master of Science) in Electrical Engineering – Ingegneria Elettrica or in Mechanical Engineering – Ingegneria Meccanica intending to enrol in the Study Plan (Piano di Studio Autonomo) "Mobility: infrastructures and services" sponsored by Ferrovie dello Stato Italiane in the a.y.2017/2018.

art. 2

Requirements for participation

The competition is open to that meet the following conditions:

1. enrolment in the Laurea Magistrale (equivalent to Master of Science) in Electrical Engineering – Ingegneria Elettrica or in Mechanical Engineering – Ingegneria in the a.y. 2016/2017;
2. income range of a.y.2016/2017 equal or less to 4th.

art. 3 **How to participate**

Candidates are required to submit the application form through the dedicated function available from On-line services <http://www.polimi.it/servizionline> (Benefits and agreements> Economic benefits) **within 12.00 noon (Italian time) of 08 September 2017.**

The closure of the on-line application is equivalent to send the participation application for this Notice of competition and implies acceptance of its contents.
It is responsibility of the candidate to verify the correct conclusion of the procedure.

After closure of the Notice, application cannot be changed any more. The candidate can delete the application and resubmit a new one before the Notice deadline.

Failure to close the application or its incompleteness will implies the exclusion from the evaluation procedure.

art. 4 **Granting of scholarship**

The reserve assignment of scholarships will be decided on the basis of a first ranking list made by the Area Sviluppo e Rapporti con le Imprese.

This ranking list will be drawn up taking into account the weighted average of exams regularly registered and useful for graduation in his/her career within the deadline of the Notice.

In the event of equal average, priority shall be given to the candidate with the lowest income.

In case of further equal values, the younger candidate will come first.

The final ranking list of scholarships will be made, after verification of the following conditions:

1. enrolment to the a.y. 2017/2018 in the 2nd year in the Laurea Magistrale (equivalent to Master of Science) in Electrical Engineering – Ingegneria Elettrica or in Mechanical Engineering – Ingegneria Meccanica within the 15/09/2017;
2. Submission of Study Plan (Piano di Studio Autonomo) “Mobility: infrastructures and services” within the 02/10/2017

All the scholarships of this competition or part of them could not be assigned, in the event that all or part of the candidates will not be considered eligible.

art. 5
General Rules

Cumulability - The scholarship can not be combined with Diritto allo Studio benefits or the relevant academic year of this Notice. The scholarship can however be combined with contributions for international mobility provided by Politecnico or other public or private entity. The scholarship can also be combined with exemptions from university fees and contributions.

Revocation: the scholarship can be revoked if the recipient is subject to disciplinary sanctions. It is still subject to revocation in case of waiver the studies and transfer to another university, current year.

Cancellation: in the event of cancellation made by the winner, the scholarship is awarded to the first suitable candidate that follows in the ranking list.

Allocation: reserve assignment of the scholarship will be notified to the winners via institutional e-mail address of the University. Real allocation of the scholarship and its next possible renewal will be notified to the winners via institutional e-mail address of the University. Within 10 days from receipt of such notifications, the winners will have to send, signed for acceptance, the dedicate forms that they will get attached. The scholarship will be allocated with a single instalment by Politecnico di Milano.

Tax treatment: assigned contributions are subject to tax purposes and applicable legislation for what concern scholarships. The allocated amount for scholarship can be considered as income from salaried employment and therefore it undergoes the same tax treatment. The expenses charged to Politecnico di Milano corresponds to IRAP rate equal to 8,5% of the amount of the scholarship.
