HAVING REGARD TO the Decree of the President of the Republic no. 445, issued on 28 December 2000;

HAVING REGARD TO articles 2 and 12 of the Decree of the President of the Council of Ministers issued on 9 April 2001, "Uniformità di trattamento sul diritto agli studi universitari" [uniformity of treatment regarding the right to university education];

HAVING REGARD TO the Regulations of the "Prof. Ing. Giuseppe Pastonesi" degree prize, issued with Rectoral Decree no. 97/AG of 29/01/2002;

HAVING REGARD TO the Regulations for Administration, Finance and Accounting, issued with Rectoral Decree n. 828 prot.n.7766 of 14/03/2014, and specifically articles 75 and 79;

HAVING REGARD TO the minutes of the meeting of the Panel for the "Prof. Ing. Giuseppe Pastonesi" degree award dated 17/10/2016;

HEREBY DECREES

the issue of the call for applications for no. 1 "Prof. Ing. Giuseppe Pastonesi" - A.Y. 2015/2016 - degree award for graduates who completed a Master's Degree in Chemical Engineering - Ingegneria Chimica.

art. 1 Award characteristics and recipients

The "Prof. Ing. Giuseppe Pastonesi" degree award (€ 2,600.00 before tax and after taxes owed by the Politecnico di Milano) is for graduates who completed a Master's Degree in Chemical Engineering — Ingegneria Chimica at the Politecnico di Milano between May 2016 and April 2017 with an average exam mark of no less than 27 out of 30, attributing an additional score of 3 points out of 30 for each awarding of honours.

The Area Sviluppo e Rapporti con le Imprese rewill check the applicants meet the required criteria.



art. 2 Participation procedures

Applicants must submit their request for participation through the specific section in the Online Services http://www.polimi.it/servizionline (Benefits and agreements> Economic benefits) no later than 12.00 pm (midday - Rome time) on 15 September 2017.

Applicants must attach, through the specific procedure:

- -the degree thesis in pdf format, maximum 10 MB
- -a summary (no more than 4 pages) in pdf format, maximum 10 MB

The files must be named as Surname-Name-Type of document.pdf (for example Rossi-Mario-Tesi.pdf)

The application is complete with the submission of the request for participation in this call for applications and implies the acceptance of its rules and regulations.

Applicants are responsible for checking the procedure is properly completed.

Once the application has been completed and submitted it may no longer be changed. Applicants will be allowed to delete the request and submit it again (ex novo) before the deadline.

Failure to complete the application or to submit it means applicants will be excluded from the selection process.

In case of theses with more than one author, each co-author who intends to compete for the award will submit a separate application.

art. 3 Judging Panel

The student ranking list will be awarded by a Judging Panel designated after the expiration date of the call by a Decree of the Manager.

The Panel will create the ranking list on the basis of the applicants' curriculum and degree thesis. If several applicants have equivalent qualifications, the Panel may distribute the prize among them, provided the conditions referred to in art. 1 of the call are met.

In case of theses with more than one author, each co-author who intends to compete for the award will submit a separate application.

art. 4 General rules

Cumulability: the degree award cannot be added to other prizes awarded for the same degree thesis.

Withdrawal: if the winner waives the degree award, the prize will be assigned to the next candidate in the ranking list.

Award: the degree is paid in one instalment. The winner will be informed of the degree prize award via an e-mail sent to his/her university e-mail address after the publication of the final student ranking list. No later than 10 days from receiving the e-mail, the winners must sign and send the specific forms they will find attached to the award notification.

Taxation: the prize awarded is subject to the current laws governing the taxation of scholarships and degree prize. For taxation purposes, the sum paid for the degree prize is to be treated as income comparable to income from employment. The tax due by the Politecnico di Milano is IRAP (equal to 8.5% of the value of the degree prize).

art. 5 Processing of personal data

Pursuant to Lgs.D. 196/2003, the Area Sviluppo e Rapporti con le Imprese (the Data Controller of the supplied personal data), guarantees that the data will be used only for this procedure.

art. 6 Manager of the procedure
