HAVING REGARD TO the Decree of the President of the Republic no. 445, dated 28.12.2000;

HAVING REGARD TO articles 2 and 12 of the Decree of the President of the Council of Ministers issued on 9 April 2001, "Uniformità di trattamento sul diritto agli studi universitari" [uniformity of treatment regarding the right to university education];

HAVING REGARD TO the Regulations for Administration, Finance and Accounting, issued with D.R. no. 828 prot. no. 7766 dated 14/03/2014 and, in particular, articles 75 and 79;

HAVING REGARD TO letter prot. no. 27558 dated 16/03/2018, in which Mr. Aldo Brambilla, president of Rotary Club Milano Sud Ovest expresses the intention to donate to the Politecnico di Milano the sum of € 1.500,00 to provide a scholarship for disabled students of the Schools of the Politecnico di Milano;

HAVING REGARD TO D.Dir. no. 2123 prot. no. 30533 issued on 26/03/2018, in which the donation from Rotary Club Milano Sud Ovest is formally accepted;

DECRETA

The issue of the call for applications **for n.1 scholarship** for **disabled students** of the Politecnico di Milano for the academic year 2017/2018.

art. 1 Recipients and scholarship features

The scholarship, with gross amount of € 1.500,00 including costs borne by the Politecnico di Milano, are intended for students:

-Enrolled in in Laurea (equivalent to a Bachelor of Science) from 2013/2014 a.y. to 2015/2016 a.y.



- -Enrolled in in Laurea Magistrale (equivalent to a Master of Science) from 2014/2015 a.y. to 2016/2017 a.y.
- -Enrolled in the single-cycle Laurea Magistrale (equivalent to a Master of Science) from 2011/2012 a.y. to 2015/2016 a.y.

with a percentage **of disability greater than or equal to 30%** according to the art.3 comma 1, law 104/1992.

The students must be regularly registered at 2017/2018 a.y. within the deadline of the call.

art. 2 How to participate

Candidates are required to submit the application form through the dedicated function available from On-line services http://www.polimi.it/servizionline (Exemptions and partnership agreements -> Student bursaries, degree awards, exemptions) within 12.00 noon (Italian time) of 24 April 2018.

Applicants must attach, via the specific procedure, in PDF format with a maximum of 10 MB each:

- -last updated documentation issued by the ASL stating the percentage of disability
- -ISEE 2018

The files must be named as Surname-Name-Type of document.pdf (for example Rossi-Mario-ASL.pdf)

The closure of the on-line application is equivalent to send the participation application for this Call and implies acceptance of its contents.

It is responsibility of the candidate to verify the correct conclusion of the procedure.

After closure of the Call a receipt can be printed and the application cannot be changed any more. The candidate can delete the application and resubmit a new one before the Call deadline.

Failure to close the application or its incompleteness will implies the exclusion from the evaluation procedure.

art. 3 Award of the scholarship

The assignment of scholarships will be decided on the basis of the ranking list made by the Area Sviluppo e Rapporti con le Imprese.



The ranking list will be formulated giving priority to the applicant with **the highest percentage of disability**.

In the event of equal percentage of disability, priority shall be given to the candidate with **the lowest ISEE 2018**.

In the event of equal ISEE, priority shall be given to the candidate with the **fewest** academic years of registration for his program.

In the event of a further tie, priority shall be given to the candidate with the highest score

calculated using this formula: WEIGHTED AVERAGE X RECORDED CFU

Will be considered the exams that can be used for graduation purposes, taken and duly recorded in their career before the closing date of the call.

The scholarship of this competition could not be assigned, in the event that all or part of the candidates will not be considered eligible.

art. 4 General Rules

Cumulability —This scholarship may not be combined with other forms of financial assistance awarded by the Politecnico, in particular with Diritto allo Studio benefits, for the relevant academic year of this Call. The scholarship can however be combined with contributions for international mobility provided by Politecnico or other public or private entity. The scholarship can also be combined with exemptions from university fees and contributions.

Allocation: the assignment of the scholarship will be notified to the winners via institutional e-mail address of the University. Within 10 days from receipt of such notifications, the winners will have to send, signed for acceptance, the dedicate forms that they will get attached. The scholarship will be allocated with a single instalment by Politecnico di Milano.

Cancellation: in the event of cancellation made by the winner, the scholarship is awarded to the first suitable candidate that follows in the ranking list.

Revocation: the scholarship can be revoked if the recipient is subject to disciplinary sanctions. It is still subject to revocation in case of waiver the studies and transfer to another university, current year.

Tax treatment: assigned contributions are subject to tax purposes and applicable legislation for what concern scholarships. The allocated amount for scholarship can be considered as income from salaried employment and therefore it undergoes the same tax treatment. The expenses charged to Politecnico di Milano corresponds to IRAP rate equal to 8,5% of the amount of the scholarship.

Self-certification of data: if controls by the Politecnico di Milano establish that the information supplied was false, all benefits obtained will be withdrawn.



art. 5 Data Treatment

In accordance with Legislative Decree No. 196 of 30/06/2003, the Area Sviluppo e Rapporti con le Imprese is responsible for personal information provided and guarantees that they will be used exclusively for purposes related to this procedure.

art. 6 Head of the procedure
