HAVING SEEN Italian Presidential Decree 28.12.2000, no. 445;

HAVING REGARD to Articles 2 and 12 of Italian Prime Ministerial Decree of 9 April 2001, "Equal treatment on the right to university studies";

HAVING REGARD to the Regulation for Administration, Finance and Accounting, issued with Rector's Decree no. 828, ref. no. 7766 of 14/03/2014 and in particular Art. 75 and 79;

HAVING CONSIDERED the University's commitment to favour the inclusion of diversities and gender issues, expressed through the strategic programme POP – Pari Opportunità Politecniche (Politecnico Equal Opportunities);

HAVING REGARD to the letter, ref. no. 150751 of 14/10/2020 with which Elisabetta Baudino expresses the intention to donate to Politecnico di Milano the total sum of €15,000.00 aimed at paying for study scholarships to support female students enrolled on those master's degree courses in Engineering at Politecnico di Milano that are statistically less attended;

HAVING REGARD to Managerial Decree no. 7674 ref. no. 162008 of 02/11/2020, which declares the acceptance of the donation offered by Elisabetta Baudino;

HAVING REGARD to the letter, ref. no. 156900 of 23/10/2020 with which Giuseppe Falco, legal representative of Soc Boston Consulting Group, expresses the intention to donate to Politecnico di Milano the sum of €8,680.00 for two years aimed at providing study scholarships to support female students enrolled on those master's degree courses in Engineering at Politecnico di Milano that are statistically less attended;

HAVING REGARD to Managerial Decree no. 7672 ref. no. 162002 of 02/1/2020 which declares to accept the donation provided by the company Boston Consulting Group;

HAVING REGARD to the letter, ref. no. 114782 del 29/07/2020 with which Paolo Maria Manzoni, legal representative of the Company Q-WASTE expresses the intention of the Company itself to donate to Politecnico di Milano the sum of €1,500.00 in support of the initiatives of the programme POP − PARI OPPORTUNITA' POLITECNICHE (Politecnico Equal Opportunities) with particular interest for study scholarships;

HAVING REGARD to Managerial Decree no. 5847 ref. no. 127355 of 03/09/2020 which declares to accept the donation provided by the company Q-WASTE;

HAVING REGARD to the agreement no. 8896 ref. no. 173246 of 18/11/2020 signed with Intesa Sanpaolo S.p.A. and Intesa Sanpaolo Innovation Center S.p.A, for the payment of a contribution of the total amount of €160,000.00 in favour of Politecnico di



Milano and aimed at paying for study scholarships to facilitate the choices of young female students and to encourage their orientation towards study and career paths in the field of STEM;

HEREBY DECREES

The issuance of the Call for Applications for 6 study scholarships "Girls@Polimi per le studentesse dei corsi di laurea magistrale"a.y. 2020/2021.

Art.1 Introduction

Politecnico di Milano, through the strategic programme POP – Pari Opportunità Politecniche (Politecnico Equal Opportunities), attempts to encourage the inclusion of diversities and to address gender issues.

It was precisely to support female students of Engineering course with low female attendance, to achieve their career plans in the field of innovation and technology, the sector that is known as STEM (acronym for Science, Technology, Engineering and Mathematics), that the Girls@Polimi study scholarships were established.

Elisabetta Baudino with the supplementation of Q-WASTE covers no. 1 scholarship. Boston Consulting Group covers no.1 scholarship. Intesa Sanpaolo-and Intesa Sanpaolo Innovation Center cover no.4 scholarships.

Art. 2 Characteristics of the study scholarship and recipients

The 6 study scholarships, of the gross amount of €8,000.00 including costs borne by Politecnico di Milano, are intended for female students enrolled for the first time in the a.y. 2020/2021 on master's degree courses (equivalent to a Master of Science) in Engineering at Politecnico di Milano with an attendance rate no higher than 35%. Courses with attendance higher than 35% are considered by the University's gender neutral strategic plan.

The winners may be offered mentoring paths.

The study scholarships **are renewable** for the same amount for the next academic year if the requirements are met as envisaged in Art. 6 of this Call.

Art. 3 Participation requirements

The scholarships are intended for female students who, by the deadline of the Call:

- are enrolled for the first time in the a.y.2020/2021 on one of the following master's degree courses (equivalent to a Master of Science) at Politecnico di Milano:

- 2. Automation and Control Engineering Ingegneria dell'Automazione



- 3. Civil Engineering for Risk Mitigation
- 4. Computer Science and Engineering Ingegneria Informatica

- 6. Electronics Engineering Ingegneria Elettronica
- 7. Energy Engineering Ingegneria Energetica
- 8. Engineering Physics Ingegneria Fisica
- 9. Geoinformatics Engineering Ingegneria Geoinformatica
- 10. Ingegneria Civile / Civil Engineering
- 11. Ingegneria della Prevenzione e della Sicurezza nell'Industria di Processo
- 12. Management Engineering Ingegneria Gestionale
- 13. Materials Engineering and Nanotechnology Ingegneria dei Materiali e delle Nanotecnologie
- 14. Mathematical Engineering Ingegneria Matematica

- they have taken and duly registered in their career **at least 15 ECTS** useful for achieving the qualification;
- have a weighted average of exams taken and recorded of not less than 24/30
- enrolled on the degree course (equivalent to a Bachelor of Science) in the a.y. 2017/2018 and achieved the respective qualification in the a.y. 2019/2020;

The Research, Innovation and Corporate Relations Division will ascertain possession of the requirements present in the IT archive of Politecnico di Milano.

Art. 4 How to participate

Applicants must submit the application using the specific function available from online Services http://www.polimi.it/servizionline (Agevolazioni e Convenzioni > Borse di studio, premi di laurea, esoneri, bandi generici [Subsidies and Conventions > Scholarships, degree prizes, exonerations, generic notices]) within 12.00 noon (Italian time) of 31 March 2021.

Students who have not achieved the degree qualification (equivalent to a Bachelor of Science) **at Politecnico** di Milano must attach in pdf format, of a maximum 5 MB, by way of the specific procedure:

-self-certification form of the qualification

The form is available at the link indicated above.

The completion of the online application is equivalent to submitting an application for participation in this call for applications, and implies acceptance of its contents.

It is the applicant's responsibility to check that they have properly completed the procedure.



After having completed and submitted the application, the applicant may print a receipt and the application may no longer be edited. The applicant will, however, have the option of deleting the application and submitting a fresh application before the deadline set out in this call for applications.

Failure to complete and submit the application, submitting an incomplete application or submitting inadequate documents will result in the applicant being excluded from the assessment procedure.

Art. 5 Assignment of the scholarship

The assignment of the scholarships is decided based upon a ranking drawn up by the Research, Innovation and Corporate Relations Division.

The ranking will be formulated based upon the score determined by the formula:

(WEIGHTED AVERAGE x ECTS RECORDED) + ECONOMIC CONDITION SCORE (at the Call deadline)

The economic condition score is determined as follows:

2021 ISEE/ISEEU	SCORE
from €0 to €23,120	100
from €23,121 to €27,000	100
from €27,001 to €31,000	90
from €31,001 to €40,000	80
from €40,001 to €51,000	70
from €51,001 to €63,000	70
from €63,001 to €75,000	50
from €75,001 to €95,000	50
from €95,001 to higher amounts	25

To that end, the **valid and compliant 2021 ISEE** (equivalent **ISEEU** for those not earning income in Italy), found in the University's **database by the call deadline** will be considered.

In the absence of a valid and compliant 2021 ISEE/ISEEU the student will be attributed, solely for the purposes of this ranking, the highest ISEE/ISEEU (€95,001).

In the case of equal scores, priority will be given to candidates away from home, namely those who do not reside in cities and/or provinces of Milan, Bergamo, Como; Varese, Monza-Brianza.



If the applicants are still equal, priority will be given to the youngest applicant.

The available scholarships may not all be assigned if the applicants are found to be unsuitable.

The winners will be invited to a meeting with the donors.

Art. 6 Renewal of scholarships

The winners of the scholarships "Girls@Polimi per le studentesse dei corsi di laurea magistrale"a.y. 2020/2021 may obtain the renewal of the scholarship for the next academic year if the requirements indicated below are met, maintaining a weighted average of not less than 24/30:

1st renewal: enrolment to a.y.2021/2022 on a degree course in

Engineering indicated in Art.3 by the deadline scheduled in the

academic year calendar

taking and recording in the career at least **35 ECTS** useful for achieving the qualification scheduled by the study plan by

30/09/2021

The aforementioned requirements will be verified by the Research, Innovation and Corporate Relations Division allowing for the automatic renewal of the scholarship.

Art. 7 General rules

Accumulation - The scholarship cannot be combined with other scholarships or other forms of financial aid provided by Politecnico for the same academic year of reference to this Call. **The scholarship, on the other hand, can be combined with the Diritto allo Studio scholarship and benefits,** and with the international mobility contributions provided by the Politecnico or by other public or private entities. The scholarship may also be combined with exemptions from tuition fees and contributions.

Revocation: the scholarship may be revoked if the beneficiary has been subject to disciplinary sanctions. Moreover, it will be revoked if the student withdraws from her studies or transfers to another university during the year.

Waiver: in the event of waiver and/or in any case failure to deliver the forms by the winner, the assignment will be transferred to the next suitable applicant in the ranking.

Payment: the assignment of the scholarship and any renewal will be communicated to the winner at the University's institutional email address. Within 10 days from the receipt



of this communication, the winner must send the specific forms that she receives attached to the award and renewal notification, signed for acceptance.

The scholarship will be paid in a lump sum by Politecnico di Milano.

If the scholarship is not paid in view of the failure by the person entitled to renew the same, the remaining funds will be used to establish a new call.

Tax status: the payments awarded are subject to taxation, in accordance with the legislation in force on study scholarships. The amount paid as a scholarship is considered the equivalent of employment income, and as such is subject to the same taxation. The costs borne by Politecnico di Milano correspond to the IRAP rate amounting to 8.5% of the amount of the scholarship.

Art. 8 Person responsible for the selection process

Politecnico di Milano (henceforth also *Politecnico*), in the role of Data Controller, based in Piazza Leonardo da Vinci 32, 20133 Milan – General Management -, hereby informs you of the methods of processing your personal data, in compliance with Regulation (EU) 2016/679 of 27 April 2016 on the protection of personal data and respective implementing regulations (henceforth also the *Regulation*).

The Controller of processing of the data you have provided is the Head of the Research, Innovation and Corporate Relations Division.

A. PERSONAL DATA COLLECTED

The personal data regarding you collected and processed by Politecnico are (a) the data provided by you upon registration or enrolment, such as name, surname, date and place of birth, sex, tax code, nationality, residential address, telephone and email contact details, educational qualifications; (b) the data collected upon submitting your application, particularly those relating to your academic career and economic condition.

B. PURPOSES AND METHODS OF PROCESSING

Your personal data may be processed for the following purposes:

1. for the public interest of verifying requirements for participation in the competition according to the criteria set forth in this call for applications and all other legal purposes, including statistical

In relation to the aforesaid purposes, the data will be processed by Politecnico di Milano using manual, computerised and electronic tools, in a manner pertinent and limited to what is necessary with respect to the purposes for which the data are processed, and in any case in such a way as to guarantee the utmost security and confidentiality and always in full compliance with current legislation.

C.MANDATORY OR OPTIONAL PROVISION OF DATA

The provision of data for the purposes set forth in section B point 1 is mandatory; any refusal to provide them will result in the inadmissibility of the application and immediate exclusion from the process.

D. SCOPE OF CIRCULATION AND COMMUNICATION OF DATA

F.STORAGE AND ANY TRANSFER OF PERSONAL DATA

Your personal data will be stored at Politecnico di Milano and will not be transferred to a third country.

G. DATA STORAGE PERIOD

H. YOUR RIGHTS

You have the right to:
