HAVING REGARD to the Decree of the President of the Republic 28.12.2000, n. 445;

**HAVING REGARD** to Articles 2 and 12 of Ministerial Decree of 9 April 2001, "Equal treatment regarding the right to higher education";

**HAVING REGARD** to Regulations for Administration, Finance and Accounting, issued by Rectoral decree n. 828 prot.n. 7766 of 14/03/2014 and in particular Articles 75 and 79;

**HAVING REGARD** to the letter prot. n. 177413 del 21/10/2021 by which Ana Amo Lacorzana, legal representative of the Company Amazon Italia Services Srl, expresses the intention to give to Politecnico di Milano the amount of € 19,530.00 for the provision of n.1 scholarship for female students of Bachelor of Science in Mathematical Engineering and Computer Science and Engineering programmes of Politecnico di Milano.;

**HAVING REGARDS** to Executive Decree n. 10079/2021 Prot n. 187924 del 03/11/2021 by which is declared the donation acceptance provided by Company Amazon Italia Services Srl:

### **HEREBY DECREES**

The issuing of the call for n. 1 scholarship "Amazon Women in Innovation Bursary for Politecnico di Milano" a.y. 2021/2022.

### Art. 1 Characteristics of the scholarship and recipients

This n.1 scholarship, with a gross amount of €6,000.00, net of any charges payable to the Politecnico di Milano, is intended for female students enrolled for the first time in the a.y. 2021/2022 in the Bachelor of Science in Mathematical Engineering and Computer Science and Engineering programmes of Politecnico di Milano.

The aim of the scholarship is to help a female student to realize her career projects in the field of innovation and technology, that sector which is called Stem (acronym for Science, Technology, Engineering and Mathematics).

The winner will benefit from a mentorship programme provided by an Amazon manager during the study programme and will have the opportunity to become a positive example for female students wishing to undertake their studies in the Stem sector, by telling them about her experiences.

This scholarship **can be renewed** for the same amount for the following two academic years if the requirements provided for under Article 5 of this competition notice are fulfilled.



# Art. 2 Participation requirements

Female students can participate in this competition, within the deadline of the call, if:

- they are enrolled for the first time in the a.y. 2021/2022 in the Bachelor of Scinece in Mathematical Engineering and Computer Science and Engineering programmes of Politecnico di Milano;
- they have passed and regularly registered in the career **at least 20 CFU** to obtain the qualification;
- they have a weighted average of the exams useful for obtaining the qualification not lower than **24/30**;

The Research, Innovation and Corporate Relations Division will attest the possession of requirements available in the computerized archive of Politecnico di Milano.

# Art. 3 How to participate

Candidates are required to submit the application form through the dedicated function available from On-line services <a href="http://www.polimi.it/servizionline">http://www.polimi.it/servizionline</a> (Exemptions and partnership agreements -> Student bursaries, degree awards, exemptions, generic calls) within 12.00 am (Italian time) of 31 March 2022.

The closure of the on-line application is equivalent to send the participation application for this Call and implies acceptance of its contents.

It is responsibility of the candidate to verify the correct conclusion of the procedure.

After submitting the application, a receipt can be printed and the application cannot be changed any more. The candidate can delete the application and resubmit a new one before the Call deadline.

Failure to complete and submit the application, submitting an incomplete application or submitting inadequate documents will result in the applicant being excluded from the assessment procedure.

## Art. 4 Granting of scholarship

The assignment of scholarship will be decided on the basis of a ranking list made by the Area Development and Relations with Enterprises.

The female candidate with worst economic conditions will come first,.

The ranking list will be drawn up considered the student's ISEE certificate (equivalent ISEEU for those without income in Italy) 2022 valid and compliant according to the University database by the end of the call.



In the absence of a valid and compliant 2022 ISEE/ISEEU the student will be attributed, solely for the purposes of this ranking, the highest ISEE/ISEEU (€95,001).

In case of equal result, priority is given to the candidate with the highest number of CFU. In case of further equal result, priority is given to the candidate with the highest weighted average.

Finally, the youngest candidate will be given priority.

The scholarship could not be assigned if the candidates are not suitable.

## Art. 5 Renewal of scholarships

The recipient of the scholarship "Amazon Women in Innovation Bursary for Politecnico di Milano" a.y. 2021/2022 can obtain the renewal of scholarship for the following two academic years if the conditions below are met:

1st renewal: registration to the a.y. 2022/2023 to one of the Engineering

Study programmes of Politecnico di Milano within the deadline

provided by the calendar of the academic year

at least 45 CFU, passed and registered in the career, useful to

obtain the qualification of the study plan by 15/10/2022

**2nd renewal:** registration to the a.y. 2023/2024 to one of the Engineering

Study programmes of Politecnico di Milano within the deadline

provided by the calendar of the academic year

at least 87 CFU, passed and registered in the career, useful to

obtain the qualification of the study plan by 15/10/2023

The aforementioned requirements will be verified by the Research, Innovation and Corporate Relations Division, in order to allow the automatic renewal of the scholarship.

### Art. 6 General Rules

**Cumulability** –This scholarship may not be combined with other scholarships or forms of financial assistance awarded by the Politecnico, for the relevant academic year of this Call. **The scholarship can however be combined with Diritto allo Studio scholarship and benefits**, contributions for international mobility provided by Politecnico or other public or private entity. The scholarship can also be combined with exemptions from university fees and contributions.



**Allocation:** the assignment of the scholarship and any renewal will be communicated to the winner at the University's institutional email address. Within 10 days of receiving that notification, the winner must return the relevant forms attached to the award and renewal notification, signed for acceptance.

The scholarship will be paid in a lump sum by Politecnico di Milano.

If the scholarship is not paid and/or in view of the failure by the person entitled to renew the same, the remaining funds will be used to establish a new call.

**Renunciation:** in case the winner renounces or if the forms are not provided within the deadline, the allocation is awarded to the first suitable candidate that follows in the ranking list.

**Revocation**: the scholarship can be revoked if the recipient is subject to disciplinary sanctions. It is still subject to revocation in case of renunciation of studies or transfer to another University during the current year.

**Tax treatment:** assigned contributions are subject to tax purposes and applicable legislation for what concern scholarships. The allocated amount for scholarship can be considered as income from salaried employment and therefore it undergoes the same tax treatment. The expenses charged to Politecnico di Milano corresponds to IRAP rate equal to 8,5% of the amount of the scholarship.

# INFORMATION IN ACCORDANCE TO ARTICLE 13 OF THE EUROPEAN GENERAL REGULATIONS ON DATA PROTECTION

With this document, Politecnico di Milano (hereinafter also *Politecnico*), as Data Controller, based in Piazza Leonardo da Vinci 32, 20133 Milan - General Management -, informs you about the processing of your personal data, in compliance to (EU) Regulation 2016/679 of 27 April 2016 on the protection of natural persons with regard to personal data processing and related implementing legislation (hereinafter also the *Regulation*).

The Data Processor is the Director of the Area Development and Relations with Enterprises.

### A. PERSONAL INFORMATION ACQUIRED

Your personal data collected and processed by Politecnico are **(a)** those you have provided at the time of registration or enrolment, such as name, surname, date and place of birth, sex, fiscal code, nationality, address of residence, telephone numbers and email addresses, qualifications; **(b)** data collected at the time of application, in particular those related to the academic career, as well as data related to the economic condition.

#### **B. PURPOSES AND METHODS OF TREATMENT**

Your personal data may be processed for the following purposes:

- 1. for the public interest, to verify the requirements for participation in the competition, according to the criteria set out in this call and for any other purpose required by law, including statistical purposes
- 2. to inform the company Amazon Italia Services Srl about the result of the call, in order to provide the mentoring and communication activities, in this case the company will be considered as a different data controller

In relation to the aforementioned purposes, the data processing by Politecnico di Milano will take place using manual, computerized and telematic tools in relation and limited to what is necessary with respect to the purposes for which they are processed and, in any case, in order to guarantee the maximum security and confidentiality and always in full compliance with current legislation.

### C.COMPULSORY OR OPTIONAL NATURE OF PROVIDING DATA

## E. STORAGE AND POSSIBLE TRANSFER OF PERSONAL DATA

Your personal data will be stored at Politecnico di Milano and will not be transferred to a third country.

## F.STORAGE PERIOD OF PERSONAL DATA

Your personal data will be kept for the time strictly necessary to ensure the implementation of all what required by the call, unless the storage of data for a longer period is required for purposes related to public interest. In case of data storage for longer periods, Politecnico guarantees compliance with the principle of data minimization as per Article 89, paragraph 1 of the Regulations.

#### **G. YOUR RIGHTS**

We remind you that you have the right:

to obtain information related to the procedures through which your data are processed and any other information required by Article 15 of the Regulations (so called *right of access*)

to obtain the correction of inaccurate personal data pursuant to Article 16 of the Regulations (so called *right to correct*)

to obtain a limitation on the processing of your personal data ex

Article 18 of the Regulations (so called *right to limitation of personal data processing*); to object to the processing of your personal data in the cases and ways provided by Article 21 of the Regulations (so called *right to object*)
