## HEREBY DECREES

The issuance of competition notice for **n. 20 scholarships** in the Honours Programme "Urban Regeneration and large scale urban developments"

# art. 1 Recipients and scholarship features

The n. 20 scholarships, each one with gross amount of €2,000, deductible expenses including charged to Politecnico di Milano, are intended for students enrolled in the second year of one of the following Master of Science programs: Architecture and Urban Design; Architecture Built Environment Interiors; Urban Planning and Policy Design of Politecnico di Milano.

The winners of the scholarship accept to participate in the Honours programme "Urban Regeneration and large-scale urban developments" offered by the School of Architecture, Urbanism and Construction Engineering in partnership with the Department of Architecture and Urban Studies and funded by Hines Italy Re. S.r.l. and Milanosesto s.p.a. The main contents of the program relate to issues and questions related to the design and development of large-scale urban projects and will have a specific reference to the case of Milano Sesto (redevelopment of the former Falck Industrial site in Sesto San Giovanni).

The program schedule provides:

- a thematic Workshop (*Urban Regeneration and Large-Scale Developments*, 4Ects) and a course (*Urban Regeneration Projects, Policies and Practices*, 4Ects) that will be inserted in the second semester study plan (ACCEPTED STUDENTS WILL BE ASKED TO



MODIFY THEIR STUDY PLAN and supported by the School in the process) and taught in English.

- a study visit to relevant case studies in Europe (the scholarship is aimed at covering the travel costs).
- the opportunity of an internship at the offices of the funding companies (Hines and Milanosesto),
- the development of a final degree thesis on the topic.

## art. 2 Requirements for participation

The competition is open to students that meet the following conditions by the deadline of the call:

1. **registration** for the 2021/2022 a.y. in the following Master of Science programmes:

Architecture and Urban Design

**Architecture Built Environment Interiors** 

Urban Planning and Policy Design of Politecnico di Milano

2. **acquisition** of at least **60 CFU** regularly registered and useful for graduation in his career:

The Research, Innovation and Corporate Relations Division will attest the possession of requirements available in the computerized archive of Politecnico di Milano.

# art. 3 How to participate

Candidates are required to submit the application form through the dedicated function available from On-line services <a href="http://www.polimi.it/servizionline">http://www.polimi.it/servizionline</a> (Benefits and agreements> Economic benefits) within 12.00 noon (Italian time) of 26 January 2022.

The candidates should attach, through the specific procedure, two PDF files (max 5 MB each) with:

- curriculum vitae et studiorum
- portfolio of recent works

The files must be named as Surname-Name-Type of document.pdf (for example Rossi-Carlo-CV.pdf and Rossi-Carlo-Portfolio.pdf)



The closure of the on-line application is equivalent to send the participation application for this Notice and implies acceptance of its contents.

It is responsibility of the candidate to verify the correct conclusion of the procedure.

After closure of the Notice, application cannot be changed any more. The candidate can delete the application and resubmit a new one before the Notice deadline.

Failure to complete and submit the application, submitting an incomplete application or submitting inadequate documents will result in the applicant being excluded from the assessment procedure.

# art. 4 Granting of scholarship

The assignment of the scholarships is decided based upon a ranking drawn up by the Research, Innovation and Corporate Relations Division according to the evaluation of a specific Academic Commission.

The ranking will be formulated based upon the score determined by the formula WEIGHTED AVERAGE x ECTS RECORDED and by the evaluation of the CV and of the PORTFOLIO OF RECENT WORKS

All scholarships of this competition or part of them could not be assigned, in the event that all or part of the candidates will not be considered eligible.

The winners can be invited to a meeting with the donors.

## art. 5 General Rules

**Cumulability** –This scholarship may not be combined with other scholarships or forms of financial assistance awarded by the Politecnico, for the relevant academic year of this Notice. The scholarship can however be combined with Diritto allo Studio scholarship and benefits, contributions for international mobility provided by Politecnico or other public or private entity. The scholarship can also be combined with exemptions from university fees and contributions

**Allocation:** Successful candidate shall be notified of the allocation of the scholarship and any potential future renewals via their Polimi e-mail address. Within 3 days from receipt of such notifications, the winner must send, signed for acceptance, the dedicate forms that will be provided attached to the allocation and renewal communication.

The scholarship will be allocated with a single instalment by Politecnico di Milano.

If the scholarship is not paid, the remaining funds will be used to establish a new notice.

**Renunciation:** in case the winner renounces or if the forms are not provided within the



deadline, the allocation is awarded to the first suitable candidate that follows in the ranking list.

**Revocation**: the scholarship can be revoked if the recipient is subject to disciplinary sanctions. It is still subject to revocation in case of renunciation of studies or transfer to another University during the current year.

**Tax treatment:** assigned contributions are subject to tax purposes and applicable legislation for what concern scholarships. The allocated amount for scholarship can be considered as income from salaried employment and therefore it undergoes the same tax treatment. The expenses charged to Politecnico di Milano corresponds to IRAP rate equal to 8,5% of the amount of the scholarship.

# INFORMATION PURSUANT TO ARTICLE 13 OF THE EUROPEAN GENERAL DATA PROTECTION REGULATION

Through this document, the Politecnico di Milano (hereinafter also called *Polytechnic*), as Data Controller, with offices located in Piazza Leonardo da Vinci 32, 20133 Milan - General Management -, informs you with regard to the processing of your personal data, in compliance to Regulation (EU) 2016/679 of the European Parliament and Council dated 27 April 2016 on the protection of individuals regarding the processing of personal data and related implementing legislation (hereinafter also called the *Regulations*).

The Data Processor, of the data provided by you, is the Research, Innovation and Corporate Relations Division.

#### A. PERSONAL DATA COLLECTED

The personal data collected and processed by the Polytechnic, which regards you, is the following: (a) the data you communicated at the time of registration or enrollment, such as name, surname, date and place of birth, sex, social security number, nationality, address of residence, telephone and IT addresses, qualifications; (b) the data collected at the time of submission of the application, in particular the data relating to your academic career and economic condition.

### **B. PURPOSE AND METHOD OF PROCESSING**

Your personal data may be processed:

1. to verify eligibility requirements to participate in the competition according to the criteria set out in this announcement and for any other purpose required by law, also with the aim of processing statistical information

In relation to the aforementioned purposes, data processing by the Politecnico di Milano will take place using manual, computerized and electronic tools in a relevant manner and limited to what is necessary with respect to the purposes for which they are processed and, in any case, in order to guarantee the maximum security and confidentiality and, always, in full compliance with the legislation in force. The Politecnico will take all measures to promptly correct inaccurate data in relation to the processing purposes.

With reference to the particular data, the processing will be carried out in a proportionate manner with regard to the aim pursued, while adopting appropriate and specific measures to protect your fundamental rights.

## C. COMPULSORY AND NON-COMPULSORY DATA

Providing data, for the purposes referred to in paragraph B. point 1, is mandatory and any refusal to provide such data involves the inadmissibility of the application submitted by the student and the immediate exclusion from the procedure. Providing data for the purposes referred to in paragraph B. point 2 is optional and any refusal to provide data does not lead to any consequences.



#### D. DATA CIRCULATION AND COMMUNICATION

Your personal data will be passed on to the Polytechnic employees who will be authorized to process this data, or to natural or legal persons who provide consulting services or collaborate with the Polytechnic for the purpose of providing the selection procedures as foreseen by the competition announcement. Your personal data, also, will be sent to the donor companies to inform them about the result of the notice.

If any contact is made by a donor, please **consider that the donor is a separate and autonomous data controller.** The donor will then provide you an appropriate privacy notice.

#### E. RETENTION AND POSSIBLE TRANSFER OF PERSONAL DATA

Your personal data will be stored at the Politecnico di Milano. Your data will not be transferred to a third country.

#### F. PERSONAL DATA PERIOD OF RETENTION

Your personal data will be kept for the time strictly necessary to guarantee access to the right to study benefits, unless the retention of data for a longer period is necessary for archiving purposes in the public interest, for scientific or historical research or for statistical purposes. Should data retention be needed for longer periods, the Polytechnic guarantees compliance with the principle of data minimization pursuant to art. 89, paragraph 1 of the Regulations.

## **G. YOUR RIGHTS**

We would like to remind you that you have the right:

- to obtain information in relation to the ways in which your data is processed and any other information required by art. 15 of the Regulations (*right of access*)
- to obtain the correction of inaccurate personal data concerning you pursuant to art. 16 of the Regulations (*rectification right*)
- to obtain a limitation on the processing of personal data concerning you pursuant to art. 18 of the Regulations (*processing restriction right*);
- to oppose the processing of your personal data in the cases and under the conditions provided for by art. 21 of the Regulations (*right of opposition*)
