THE MANAGER

GIVEN the subscription of Politecnico di Milano to the IDEA League network, approved by the Academic Senate and Board of Governors during their respective meetings of 21 and 22 March 2016;

GIVEN the Challenge Programme scheduled for the a.y. 2025/26;

GIVEN the availability of economic funds;

HEREBY DECREES

the publication of the present call for the selection of **n. 8 students** that will participate in the Challenge Programme IDEA League 2025/26.

Art. 1 - Recipients

This call is open to students of all Schools of Politecnico di Milano that during the academic year 2024/25 are enrolled:

- in the 3rd year of the Laurea Triennale (equivalent to a Bachelor of Science programme) or in the 3rd year of the Laurea Magistrale a ciclo unico (equivalent to a 5-year single cycle programme);

- in the 1st year of Laurea Magistrale (equivalent to a Master of Science programme);
- in the 4th year of Laurea Magistrale a ciclo unico (equivalent to a 5-year single cycle programme)

who will confirm their enrollment at Politecnico di Milano for the a.y. 2025/26.



Art. 2 - Description of the project

The project provides four educational modules in four different locations.

There are no tuition costs.

Accommodation, breakfast, lunch, and one dinner are arranged and paid for by the partner organising the weekend.

Furthermore, a maximum gross amount of \in 1.000,00 will be provided to partially cover the costs of travel and meals, net of the fees to be paid by Politecnico, as follows:

- \in 500,00 at the beginning of the programme (in October 2025)
- \in 300,00 upon completion of the programme (in May 2026).

An additional amount of maximum € 200,00 will be provided if evidence of a **green travel** (using train, bus, or shared car) is given. The additional amount is modulated as follows:

- € 50,00 for one green return-trip;
- €100,00 for two green return-trips;
- € 200,00 for three green return-trips.

Upon completion of the programme, 5 credits can be recognized in the student's career, as surplus of credits.

Art. 3 - Presentation of the application

In order to take part in the selection, it is necessary to submit the application form available through the following link by the **28th July 2025**.

To access the application, students need to register using their Politecnico di Milano online services credentials.

In the field Student or Employee number, **students must indicate the active matriculation number on 30th April 2025**.



Art. 4 - Requirements for participation and selection procedure

Students who, **by 30th April 2025**, have obtained a weighted average of at least **27/30**, may participate in the selection, provided they have also achieved:

- **at least 140 ECTS** if enrolled in the 3rd year of a Laurea Triennale (equivalent to a Bachelor of Science programme) or in the 3rd year of the Laurea Magistrale a ciclo unico (equivalent to a 5-year single cycle programme);

- **at least 30 ECTS** if enrolled in the 1st year of a Laurea Magistrale (equivalent to a Master of Science programme);

- **at least 200 ECTS** if enrolled in the 4th year of a Laurea Magistrale a ciclo unico (equivalent to a 5-year single cycle programme);

A special Commission will be appointed to draw up the final ranking list, which will take into account:

- academic career;
- curriculum vitae;
- motivation letter.

Art. 5 - Nomination e final selection

The list of students selected to participate in the Challenge Programme will be published in our website within 4th September 2025. The list will be forwarded to the General Secretariat of IDEA League that will confirm the admission to the programme.

Participation in the programme is, in any case, subject to actual registration/enrollment in the a.y. 2025/26.
